EPA, NTP and OSHA do not designate TiO<sub>2</sub> as a carcinogen and ACGIH designates TiO<sub>2</sub> as A4 - not classifiable as a human carcinogen. TiO<sub>2</sub> is not present in this product as a dust and no airborne exposure is expected during application.

### 4. FIRST AID MEASURES
